1. This **Expression of Interest (EOI)** is not a contract or agreement.
2. Interested Company/Designers/Boutiques can submit their EOI mentioning the category/number of sequence/s they wish to do by depositing the required participation fee in cash or submitting the cheque in the name of **Asia-Pacific Communication Associates Nepal Pvt. Ltd.**
3. EOI can be submitted for both the categories or also can opt for one of the categories (**Ramp/Display**).
4. Interested participants for **Ramp** will have to submit a brief **Portfolio** along with EOI.
5. Company/Designers/Boutiques can participate by paying NRs 35000/- (In Words Thirty Five Thousand Only) for one sequence i.e. 10 dresses or 2 sequences i.e. 20 dress by paying additional fee of NRs 15,000/- (In Words Fifteen Thousand Only)
6. Additional fee of NRs. 10,000/- (In Words Ten Thousand Only), if the participant wishes to any of the foreign celebrities including Miss India title holders.
7. 30% commission will be deducted by the organizer for every sales take place during the event.
8. 2 Auto Size Photographs (Close-up) of the participating designer will have to be submitted along with the form.
9. Profile of designer should be submitted.
